Policy Updates

- New Policies in the Works! The Board has been diligently working on two new policies to enhance our community living:
 - Significant Other Policy: This aims to clarify that a significant other (at least 50 years old, long-term partner, substantial influence, romantic partner) can reside in the park with a shareholder after an application, background check and interview, even if not on the mobile home title or a shareholder. This ensures harmony while allowing significant others to live here
 - Family Policy: This will allow family members to reside in the park for longer periods than before, provided rules are followed. These policies will be discussed at the Shareholders' Board of Directors meeting this fall.

Rules & Regulations Committee & Empty Lot Discussion

- Our Rules and Regulations Committee worked tirelessly this winter, reviewing our existing doctrines and new ones. The Board of Directors (BOD) is reviewing its recommendations this summer, and a vote will take place at the annual shareholders' meeting in January.
- Important Discussion Ahead: The Empty Lot! We've received an offer for our empty lot from Michael Graham for Floridays: what we paid (\$125,000 in 2013) plus a 4% annual increase, totaling \$200,129! He ensures we retain the easement for Third and Fourth Streets. This is a big decision for our community, requiring a 2/3 majority vote from shareholders. We want to bring this up for discussion in December, including pros and cons, and any new information that is gathered. Please take time to think about this interesting opportunity!

What a fantastic season it has been at Sea Breeze! We are so grateful for our vibrant community, the hard work of our volunteers and board members, and the wonderful spirit that makes our park truly special.

We look forward to seeing you all again in the fall, but know that, as your Board of Directors, we are always available to you.
